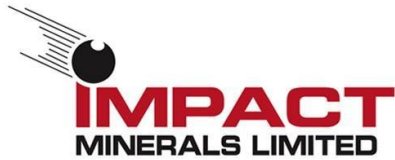
## **Impact Minerals Limited**
