ISSUE OF SHARES TO NON EXECUTIVE DIRECTORS

Pursuant to Resolution 4 and Resolution 5 passed at the Annual General Meeting held on the 27th November 2014 and as explained in the Notice of Meeting and Explanatory Statement (Announcement [27th October 2014](#)) the company has issued in lieu of Director fees 142,045 shares to Dr Markus Elsasser and 142,045 shares to Mr Paul Ingram, Non-Executive Directors of the Company.

Non-Executive Director salaries for Dr Elsasser and Mr Ingram had been set at \$30,000 per annum in prior periods. However, to conserve the Company's cash reserves Dr Elsasser and Mr Ingram have agreed that from the 1st July 2014 these fees be reduced to \$25,000 per annum and half this amount be paid in cash and half be paid in Company shares. For further details please see the Notice of Meeting and Explanatory Statement (Announcement [27th October 2014](#)).


